- 9. Ambulance Service; Building is Down minus getting gas turn on and few minor details. EMS is working on getting address changed but Town has done it part. Treasurer requested final invoice. No Action Needed
- 10.Choctaw Nation Assistance; Matt Hines shared the paperwork has been filled out and he showed council the details on what they requested etc. Motion by Coy to Approve that the paperwork be sent the Choctaw Nation for review, 2<sup>nd</sup> by Nathan; Votes: Coy Yes Chad Yes Nathan- Yes
- 11.Condemnation at 101  $4^{\text{th}}$  Street; Pat will send another letter to be mailed to owner. No Action Needed.
- 12.Collections Ordinance; Matt Hines asked Pat Layden and council if there is a time period the dept. needs to wait before sending fines to collections? Matt stated he would like to send them to collections as soon as they fail to appear to court and a warrant has been issued. Pat and Council agreed since there is not a time frame stated in the ordinance that is fine. Matt Hines also asked that council approve all fines that are paid in February-March paid in full be cut in half in hopes more people will get them paid. - 13.Police Department Business; Matthew Hines shared he looked into the cause of the difference noticed on monthly amounts the last several months. He found that many past due amounts were not being sent to Aberdeen/Collections in a timely manner as they should be. Court Clerks have been working on getting those caught up so the amount should start picking back up again, but it will take some time. Reports already show an increase in amounts had have been sent in the last couple weeks and he shared the monthly total amount. - 14. Fire Business Department; Jeff Jones shared he is still working on getting the tornado siren mobile alert setup.
