Citation Issuing Software; Police Chief shared the PD currently using Digticket and the company is raising its rate, so He found a company Tyler Technology that provides the same services and is more advanced since they can use the ISO through the PD tablets. The new software does have a high startup fee but the town will save 38,000 in the long run. Council and Matt discussed the pros and cons of both companies.
