ORDINANCE NO. 2021-010

AN ORDINANCE ESTABLISHING CITY OF SAVANNA MUNICIPAL FAILURE TO APPEAR COURT FEE UP TO \$500.00 TO ALL DEFENDANTS; DECLARING AN EMERGENCY AND SETTING AN EFFECTIVE DATE OF OCT 11, 2021.

NOW THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF SAVANNA OF THE CITY OF SAVANNA, OKLAHOMA City Code by amended to be entitled "Failure to Appear Fee", to read as follow, with the effective date of the same to be October 11, 2021, to-wit:

<u>Chapter 11 – Article 3.</u> Penalty For Failure to Appear:

In those cases, in which a defendant has given his or her written promise to appear and fails to do so, that person shall, upon conviction of his or her willful failure to appear, be fined in an amount not to exceed five hundred dollars (\$500.00), plus costs and fees. Further, a bench warrant may be issue for his or her arrest for his or her failure to appear. Such conviction for failure to appear shall not affect the underlying offense for which the person failed to appear.

AN ORDINANCE OF THE TOWN OF SAVANNA, OKLAHOMA ORDINANCE NO. 09200

AN ORDINANCE AMENDING THE EMPLOYEE RETIREMENT SYSTEM, DEFINED CONTRIBUTION PLAN FOR THE TOWN OF SAVANNA, OKLAHOMA; PROVIDING RETIREMENT BENEFITS FOR ELIGIBLE EMPLOYEES OF THE TOWN OF SAVANNA, OKLAHOMA; PROVIDING FOR ENTRY DATE; PROVIDING FOR REPEALER AND SEVERABILITY; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY BOARD OF TRUSTEES OF THE TOWN OF SAVANNA, OKLAHOMA.

Section 1. **AMENDATORY.** The Employee Retirement System, Defined Contribution Plan, of the Town of Savanna, Oklahoma, is hereby amended as reflected on the attached Exhibit "A", which is incorporated herein and adopted by reference. These amendments shall become effective on **August 1, 2021**.

Section 2. **EXECUTION AUTHORIZATION.** The City Clerk and Mayor be and they are hereby authorized and directed to execute the amended Retirement System Plan documents and to do all the other acts necessary to put said amendment into effect and to maintain IRS qualification of the Plan. The executed amended document attached hereto as Exhibit "A" is hereby ratified and confirmed in all respects.

Section 3. **SEVERABILITY.** If, regardless of cause, any section, subsection, paragraph, sentence, or clause of this ordinance, including the System as set forth in Exhibit "A" is held invalid or to be unconstitutional, the remaining sections, subsections, paragraphs, sentences, or clauses shall continue in full force and effect and shall be construed thereafter as being the entire provisions of this ordinance.

Section 4. **REPEALER.** Any ordinance inconsistent with the terms and provisions of this ordinance is hereby repealed; provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this ordinance shall be cumulative of other ordinances regulating and governing the subject matter covered by this ordinance.

Section 5. **EMERGENCY**. Whereas, in the judgment of the Board of Trustees of the Town of Savanna, Oklahoma, the public peace, health, safety, and welfare of the Town of Savanna, Oklahoma, and the inhabitants thereof demand the immediate passage of this ordinance, an emergency is hereby declared, the rules are suspended, and this ordinance shall be in full force and effect on its passage and approval.
