Police Department Business; Major Coy Holt along with Police Chief David Spears announced the police department is losing a Police Officer at the end of this week due to personal reasons, officer is leaving on good terms with the Town and the Town of Savanna feels the same towards the officer. The Town of Savanna appreciate the service he provided the Town during his employee with the Police Department. The Town of Savanna hired Daniel Brooks as the new officer to fill the open position. He is a veteran and has many years in law enforcement so Police Chief David Spears feels confident in hiring Mr. Brooks as an officer.

The \$68,850 Grant from the Choctaw Nation was Phase 1 approved but still waiting for final approval which the Town should be receiving the final letter stating the approval in the mail in the near future, so Town Clerk Katie Gragert will add the Bid(s) for the Park Project in the next meeting agenda for approval.

Major Coy Holt as stated last month at council meeting contacted the Indian Housing Authority to apologize for the error at happened with one of their housing attendants and also shared that due to the error the Town has set in place new water procedures to help avoid any future issues. The Housing Authority greatly appreciated the call and stating they will be building 10 more houses in Savanna due to the Town's good qualities like calling to correct the water issue. No Action

- 7. Fire Business Department; Fire Chief Jeff Jones stated the trucks are being serviced so the Town will be receiving invoices for Truck Maintenance. Also, Savanna has a municipal agreement with Kiowa Fire Dept. and Kiowa Fire Dept is currently having truck issues so Savanna Fire will be servicing the area at this time.

- Commercial front door 6'wide x 7' tall
- 2 front vinyl windows around 5' x 5'
- 2 side vinyl windows around 4' wide x 2' tall
- 2 offices 10' x18'
- Storage room 10' x 18' with shelves and an exterior door to exit to the back of the building
- Conference room 15' x 18'
- All framing would be done with wood
- 3 tone heat and air unit
- Every room will have 6 electrical plugs, 3 phone lines, and a coax cable
- Every room will have recessed can lights and LED lights
- The building will be in closed with sheet metal at the back of the conference room
